Please note the following terms of agreement:

1. The Reynolds Homestead agrees to care prudently for the art and to manage the sales for the artist. Sold art must remain in the exhibition until the end date. The purchaser is responsible for picking up the art within one week.
2. The Reynolds Homestead does not charge any commission fees for the sale of any art. Our commitment to economic development includes the support of local artists and the sale of their work.

DELIVERY/RETURN

3. Artwork must be delivered to the Reynolds Homestead by the stated deadline.
4. All unsold artwork must be retrieved within one week following the exhibition closing. The Reynolds Homestead will make a concerted effort to aid the prompt pick up and retrieval of hosted artwork; however, particularly in the case of negligent or absent artists, the Reynolds Homestead cannot be responsible for the security of abandoned works. Artwork left un-retrieved for more than one month will incur a \$5 per month, per piece storage fee. Artwork un-retrieved for more than 6 months following the exhibition closing will be moved or sold as needed.

DISPLAY

5. All works, where applicable, should be properly framed and delivered **READY TO HANG** (wired). The Reynolds Homestead reserves the right to remove any

pieces from exhibition that are not properly prepared. 3-D art, jewelry, clothing, etc., should be delivered with proper display materials.

PROMOTION

- 7. Artist warrants and represents that he/she created the works of art and possesses the unencumbered title and full copyright to each and all works of art submitted for exhibition.

- 8. The Reynolds Homestead reserves the right to refuse display any of the artwork that fails to meet exhibition requirements or is deemed unsuitable for display for any reason.
